



Memorandum of Understanding

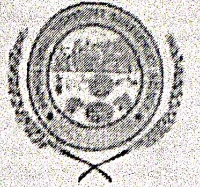

1. Rayat Shikshan Sanstha's Yashwantrao Chavan Institute of Science, Satara, India and the Project Director, Agricultural Technology Management Agency (ATMA), Satara, Department of Agriculture, Government of Maharashtra, Satara desiring to develop academic cooperation and exchange in agricultural research and extension activities, agree as follows:

- (i) To promote the exchange of publications, scientific information, lectures and research personnel between the Yashwantrao Chavan Institute of Science, Satara and the Project Director, ATMA, Satara to encourage collaboration and joint research and projects.
- (ii) For each activity under this Agreement a Plan of Work will be prepared to an appropriate level of details by the two parties, before starting the activity.
- (iii) There will be a free interchanging of scientific and technical information between the signatory organizations on all activities under this Agreement.
- (iv) Scientific results obtained as a consequence of this Agreement will be presented in appropriate conferences and lectures and/or publish as common publications (papers, books, reports, etc.).
- (v) To encourage and support common publications and participation in farmer trainings and workshops.
- (vi) To promote visits of scientists and young researchers to participate in a variety of research activities, professional development and further collaboration.
- (vii) To encourage and support the joint activities in agriculture for welfare of farmers.

3. Validity:

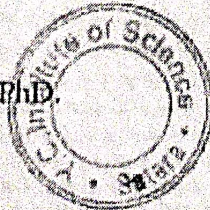
